Dear Mr. & Mrs. Kennedy:

Primero Operating, Inc. of Roswell, New Mexico hereby proposes to re-enter and recomplate the subject well between the depths of 10,667' and 12,658'. Specifically we propose to attempt completion in the Atoka Sand from 11,430' to 11,492'. We anticipate that this well will require a 320 acre spacing unit covering the S/2, Section 26, T16S-R35E, NMPM in accordance with the rules and regulations of the New Mexico Oil Conservation Division. Gross working ownership of the SW/4, and the SE/4, Section 26 are enclosed for your review and consideration. We also enclose an ownership breakdown which reflects the weighted ownership under a 320 acre S/2, Section 26 proration spacing unit. We have enclosed our AFE for your consideration in this regard.

If it is not your intention to participate in the proposed re-entry, then please contact the undersigned and Primero Operating, Inc. will endeavor to negotiate a purchase price to buy or to farmout your interest in the subject acreage. If you do not want to join and we can not negotiate either a reasonable purchase nor a farmout covering your interest, then in such event we shall initiate a compulsory pooling action against your interest before the New Mexico Oil Conservation Division.

If you plan on participating in the proposed re-entry then in such event, we shall forward to you a 1982 AAPL model form joint operating agreement covering only the depths from 10,667' to 12,658'.

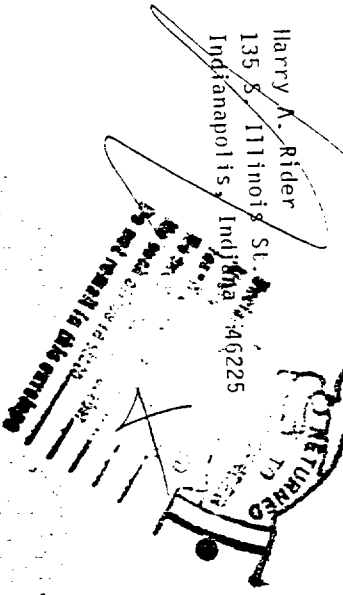
