

#### **APPLICATION**

PENWELL ENERGY, INC. ("Penwell"), through its undersigned attorneys, hereby makes application pursuant to the provisions of NMSA 1978, Section 70-2-17, for an order pooling all mineral interests from the surface to the base of the Delaware formation underlying the SE/4 NW/4 for all formations developed on 40-acre spacing of Section 5, Township 24 South, Range 33 East, NMPM, Lea County, New Mexico, and in support thereof states:

- 1. Penwell is a working interest owner in the SE/4 NW/4 of said Section 5 and has the right to drill thereon.
