




Gentlemen:

Marbob also seeks the promulgation of Special Pool Rules and Regulations for this pool including provisions for 160-acre spacing and proration units and special well location requirements, and approval of a 160-acre nonstandard spacing unit comprised of the W/2 SE/4 and the E/2 of said Section 31.
