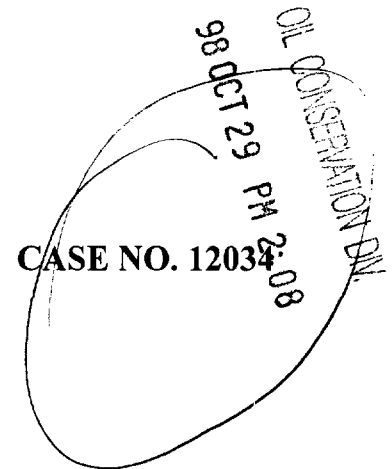

## **EXHIBIT "A"**

### **TO SUBPOENA DUCES TECUM TO MEWBOURNE OIL COMPANY IN NEW MEXICO OIL CONSERVATION DIVISION CASES 12034 AND 12051**

**PURPOSE:** The purpose of this subpoena is to provide all of the information necessary for Texaco Exploration and Production Inc., to be able to prepare its presentation in NMOCD Cases 12034 and 12051.

**PRODUCE THE FOLLOWING** documents which relate to the Catclaw Draw "1" Federal Well No. 1 located in Lot 31 of Irregular Section 1, Township 21 East, Range 25 West, NMPM:

1. Reservoir pressure data, by zone, including, but not limited to, bottom-hole pressure surveys or pressures, pressure buildup tests, surface pressure readings, daily tubing pressures and casing pressures, drill stem tests, and interference tests, with relevant information as to shutin times and production rates before shut in;
2. PVT data, PVT reports, and gas analyses by zone, including but not limited to molecular weight and API gravity;
3. All production data, by zone, including, but not limited to, all well check records (including gauges and/or charts) on a daily basis from initial testing and completion to date, showing actual production of oil, gas, and water, and associated wellhead pressures per day and per month;
4. Chronological reports including details on (a) perforating and perforation locations; (b) stimulation fluids, volumes, rates, and pressures for each treated interval, and (c) swabbing, flowing, and/or pumping results for each interval that was perforated and tested, including pre- and post-stimulation results, as applicable;
5. All C-104 and C-105 forms;
6. All correspondence and/or letter agreements with interest owners in irregular Section 1, Township 21 East, Range 25 West, NMPM, specifically including but not limited to Matador Petroleum Corporation, Penwell Energy Corporation, Devon Energy Corp., concerning the development of any acreage dedicated to or offsetting the Catclaw Draw "1" Federal Well No. 1 located in

Lot 31 of Irregular Section 1, Township 21 East, Range 25 West, NMPM;

7. All AFE's for the Catchlaw Draw "1" Federal Well No. 1 located in Lot 31 of Irregular Section 1, Township 21 East, Range 25 West, NMPM, whether such AFE's were circulated to any other person or entity or not; and

8. Any documents which refer to, reflect, or otherwise reference the actual costs associated with drilling and/or producing the Catclaw Draw "1" Federal Well No. 1 located in Lot 31 of Irregular Section 1, Township 21 East, Range 25 West, NMPM.

## INSTRUCTIONS

This Subpoena Duces Tecum seeks all information available to you or in your possession, custody or control from any source, wherever situated, including but not limited to information from any files, records, computers documents, employees, former employees, consultants, counsel and former counsel. It is directed to each person to whom such information is a matter of personal knowledge.

When used herein, "you" or "your" refers to the person or entity to whom this Subpoena Duces Tecum is addressed to including all of his or its attorneys, officers, agents, consultants, employees, directors, representatives, officials, departments, divisions, subdivisions, subsidiaries, or predecessors.

The term "document" as used herein means every writing and record of every type and description in the possession, custody or control of Mewbourne Oil Company, whether prepared by you or otherwise, which is in your possession or control or known by you to exist, including but not limited to all drafts, papers, books, writings, records, letters, photographs, computer disks, tangible things, correspondence, communications, telegrams, cables, telex messages, memoranda, notes, notations, work papers, transcripts, minutes, reports and recordings of telephone or other conversations or of interviews, conferences, or meetings. It also includes diary entries, affidavits, statements, summaries, opinions, reports, studies, analyses, evaluations, contracts, agreements, jottings, agenda, bulletins, notices, announcements, plans, specifications, sketches, instructions charts, manuals, brochures, publications, schedules, price lists, client lists, journals, statistical records, desk calendars, appointment books, lists, tabulations sound recordings, computer printouts, books of accounts, checks, accounting records, vouchers, and invoices reflecting business operations, financial statements, and any notice or drafts relating to the foregoing, without regard to whether marked confidential or proprietary.
