**LANDS:** Unless specifically indicated otherwise, information is sought as to all of the following described lands:  
T-20-S, R-33-E, Sections 16-21, 28-33;  
T-20-S, R-32-E, Sections 13, 14, 23-26, 35 & 36;  
T-21-S, R-31-E, Section 1; and  
T-21-S, R-32-E, Sections 4-6.

**TIME:** Furthermore, unless indicated otherwise, the information sought is for the period from 1995 to the present.

**INSTRUCTIONS:**

This Subpoena Duces Tecum seeks all information available to you or in your possession, custody or control from any source, wherever situated, including but not limited to information from any files, records, computers, employees, former employees, consultants, counsel and former counsel. It is directed to each person to whom such information is a matter of personal knowledge.

When used herein, MPI refers to Mississippi Potash, Inc. and any of its predecessors in interest, including New Mexico Potash or any subsidiaries, parent or sister corporations, or similarly related entities.
