Dear Mr. Stogner:

I represent Mewbourne Oil Company in connection with the above referenced cases which are scheduled for hearing tomorrow, December 3, 1998.

All of the interest owners in the south 600.01 acres of Section 1, T21S, R25E, Eddy County, New Mexico have reached an agreement to establish a 600.01 acre gas spacing and proration unit consisting of Lots 11 through 14 and 25 through 34 and the southwest quarter of the Irregular Section 1, T21S, R25E, Eddy County, New Mexico. This agreement is subject to NMOCD approval of the spacing and proration unit.

Through this agreement, the parties stipulate that their respective rights and interests in the Catclaw Draw "1" Federal No. 1 well, including Mewbourne Oil Company's right to operate same, shall not be affected or altered by the establishment of the 600.01 acre gas spacing and proration unit.


