TEXACO EXPLORATION AND PRODUCTION INC. ("Texaco") through its attorneys, Campbell, Carr, Berge & Sheridan, P. A., hereby makes application for an order amending Division Order No. R-9714 to authorize the injection of water into the Glorieta and Paddock formations in horizontally drilled dual laterals in its Vacuum Glorieta West Unit Well No. 108 located in (Unit P) of Section 36, Township 17 South, Range 34 East, NMPM, Lea County, New Mexico. Texaco also seeks the establishment of an administrative procedure whereby additional injection wells within the Vacuum Glorieta West Unit may be drilled and completed as horizontal injection wells. In support of its application, Texaco states:

1. By Order No. R-9710 dated August 25, 1992, the Division, upon the application of Texaco Exploration and Production Inc., approved the Vacuum-Glorieta West Unit which comprises 2778.86 acres, more or less, in Townships 17 and 18 South, Ranges 34 and 35 East, NMPM, Lea County, New Mexico. The unit boundaries include the following acreage in Lea County, New Mexico:

- 2. By Order No. R-9714, dated September 3, 1992, the Division approved the Vacuum-Glorieta West Unit Waterflood Project in said unit for the injection of water into the Glorieta and Paddock formations.
- 3. On July 14, 1998, the Division authorized Texaco to conduct an injectivity test in the Vacuum Glorieta West Unit Well No. 108 which had been horizontally drilled (Dual

laterals) within the Glorieta and Paddock formations to increase the sweep efficiency of these waterflood operations.

- 4. Texaco seeks to amend Order No. R-9714 which originally approved the Vacuum Glorieta West Unit Well No. 108 as a conventional vertical injection well to authorize its continued use as a horizontal injection well and to establish an administrative procedure whereby additional wells within the Vacuum Glorieta West Unit may be drilled and completed as horizontal injection wells.
- 5. Approval of this application will afford Texaco the opportunity to produce its just and equitable share of the remaining reserves in the Vacuum Glorieta West Unit Waterflood Project Area and will otherwise be in the best interest of the conservation, the protection of correlative rights and the prevention of waste.

WHEREFORE, Texaco Exploration and Production, Inc. requests that this matter be set for hearing before a duly appointed Examiner of the Oil Conservation Division on February 4, 1999, and after notice and hearing as required by law, the Division enter its Order granting this application.
