
Gentlemen:

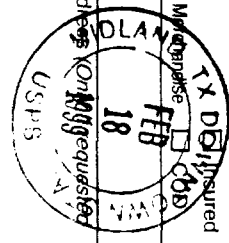
