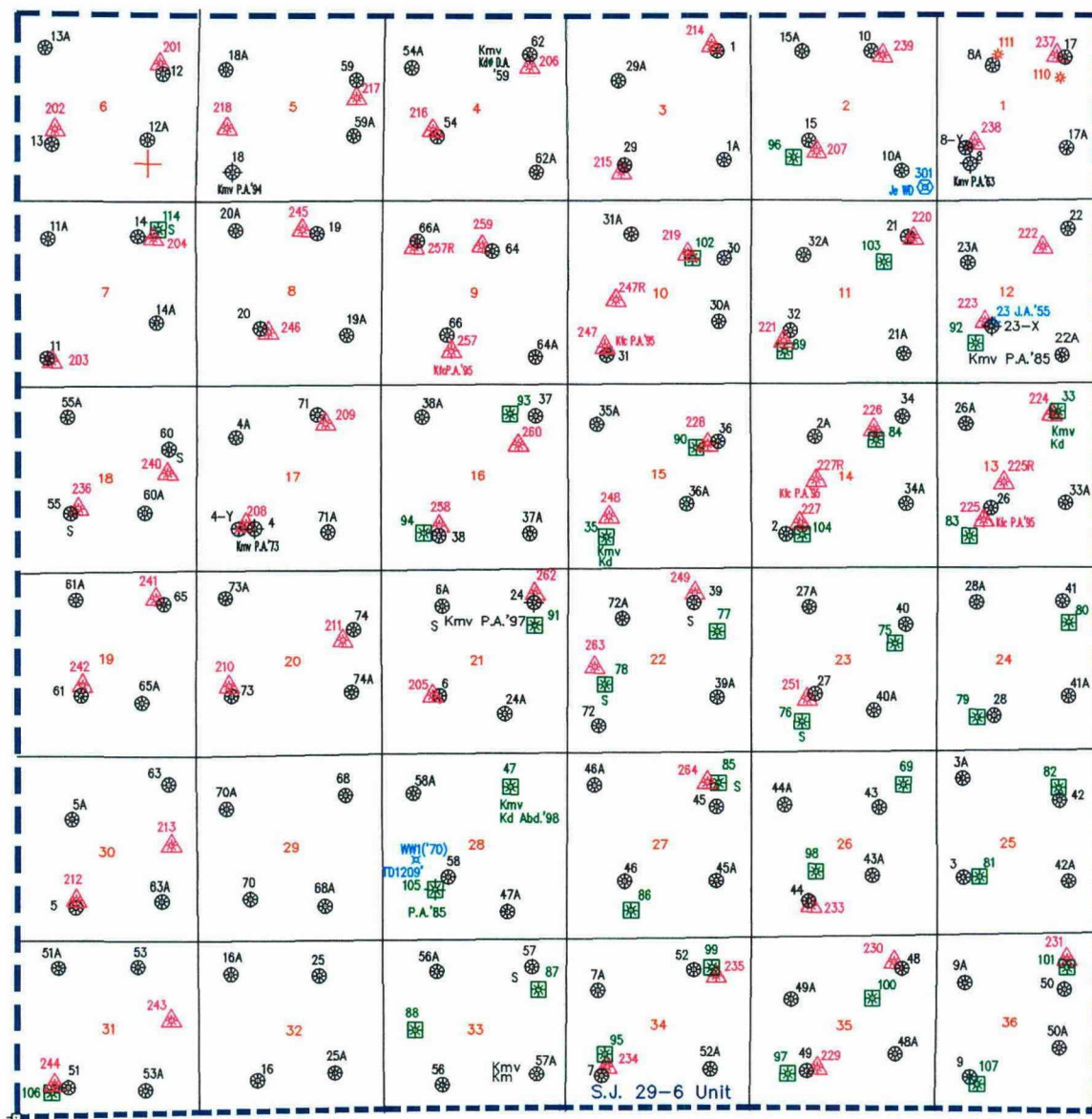

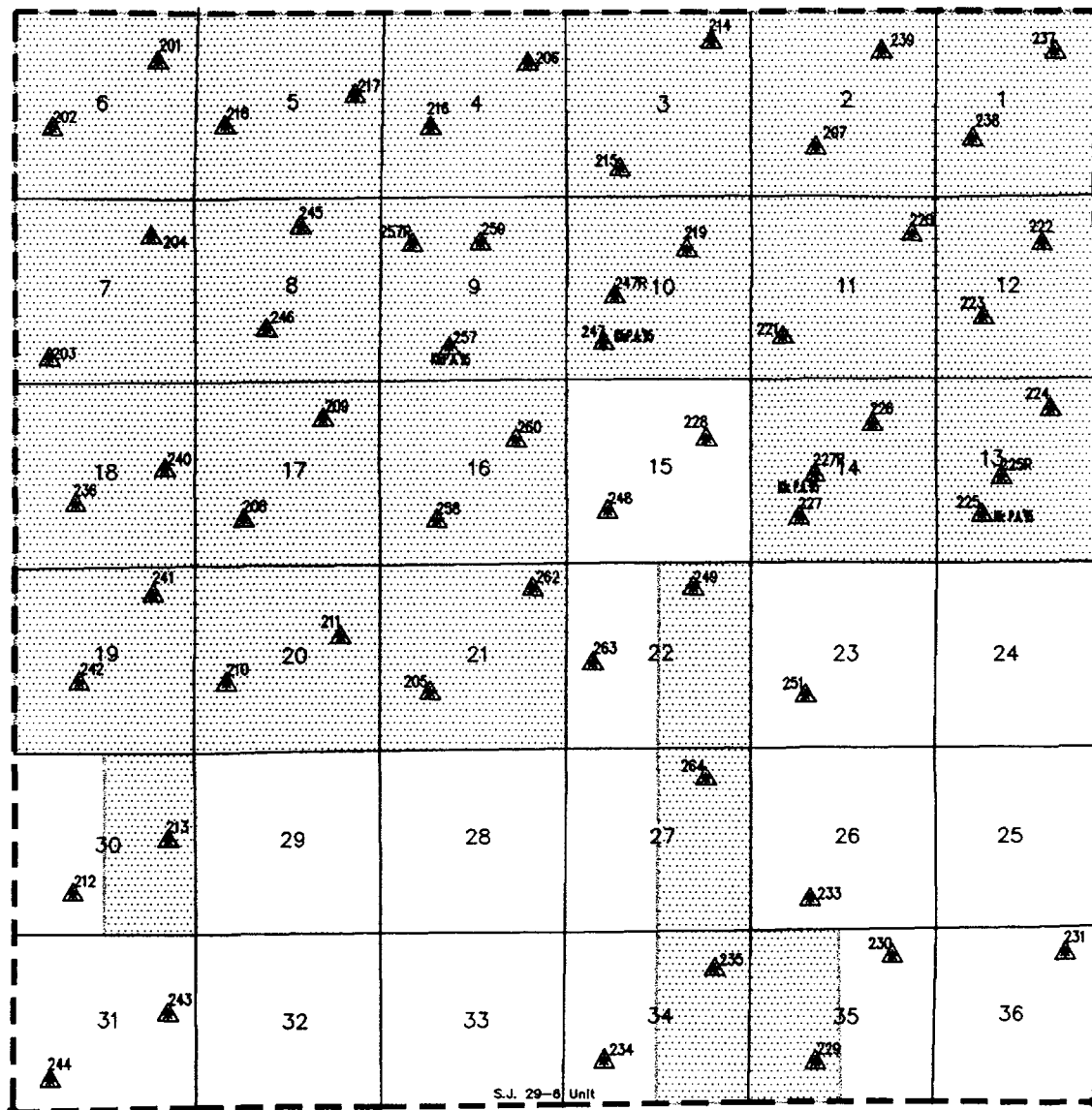

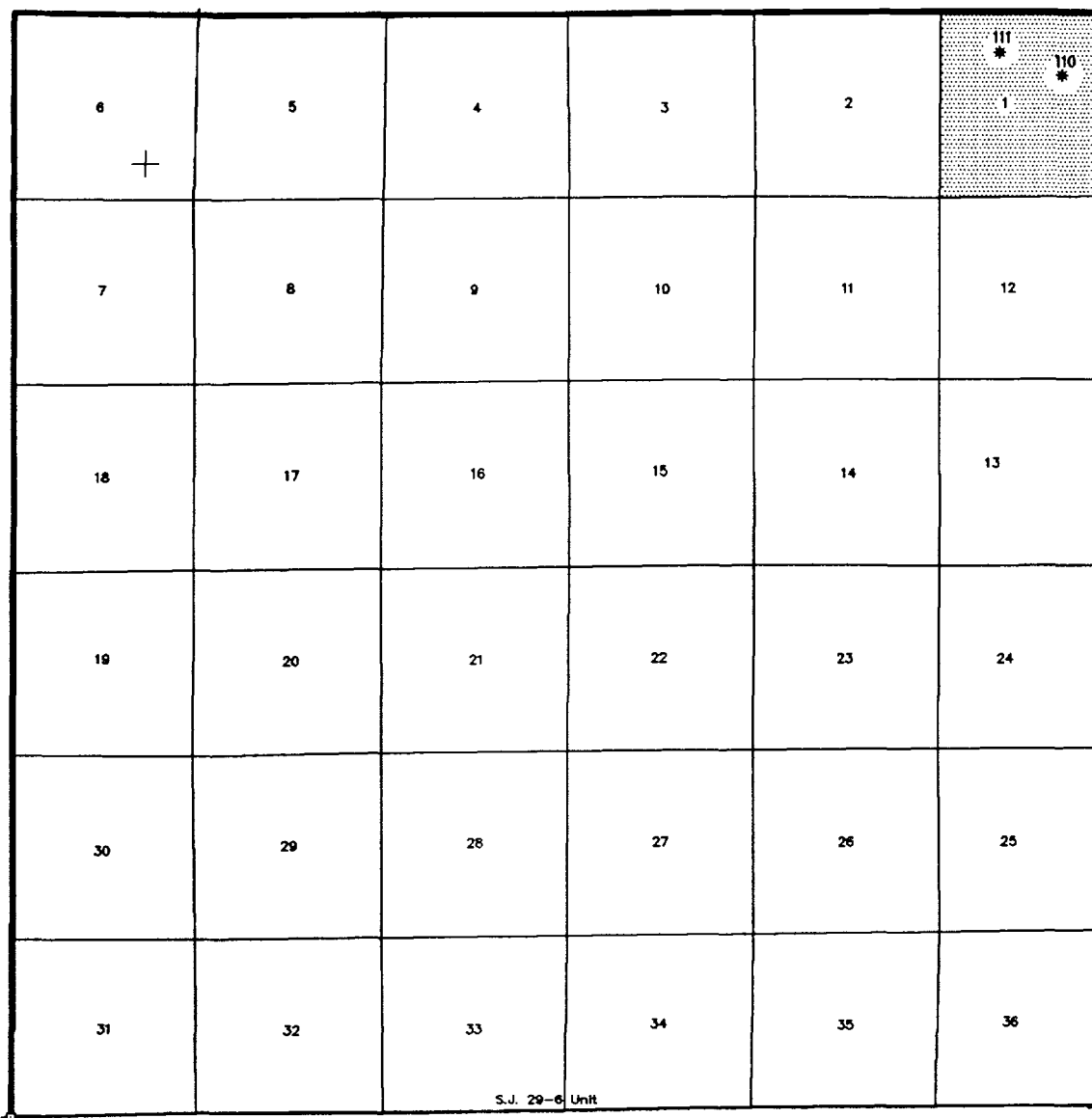

1st expansion Eff. 12/1/79*

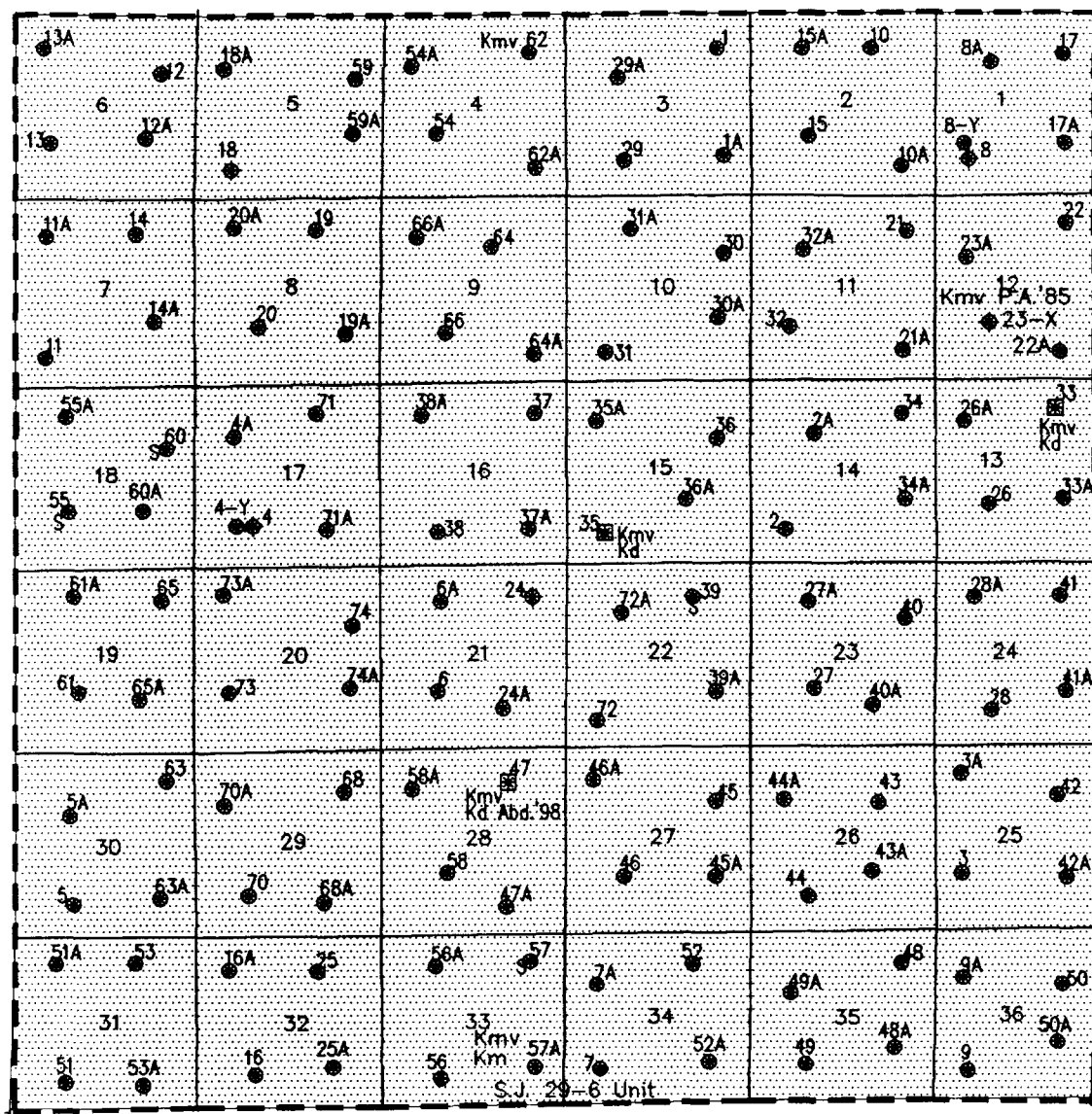

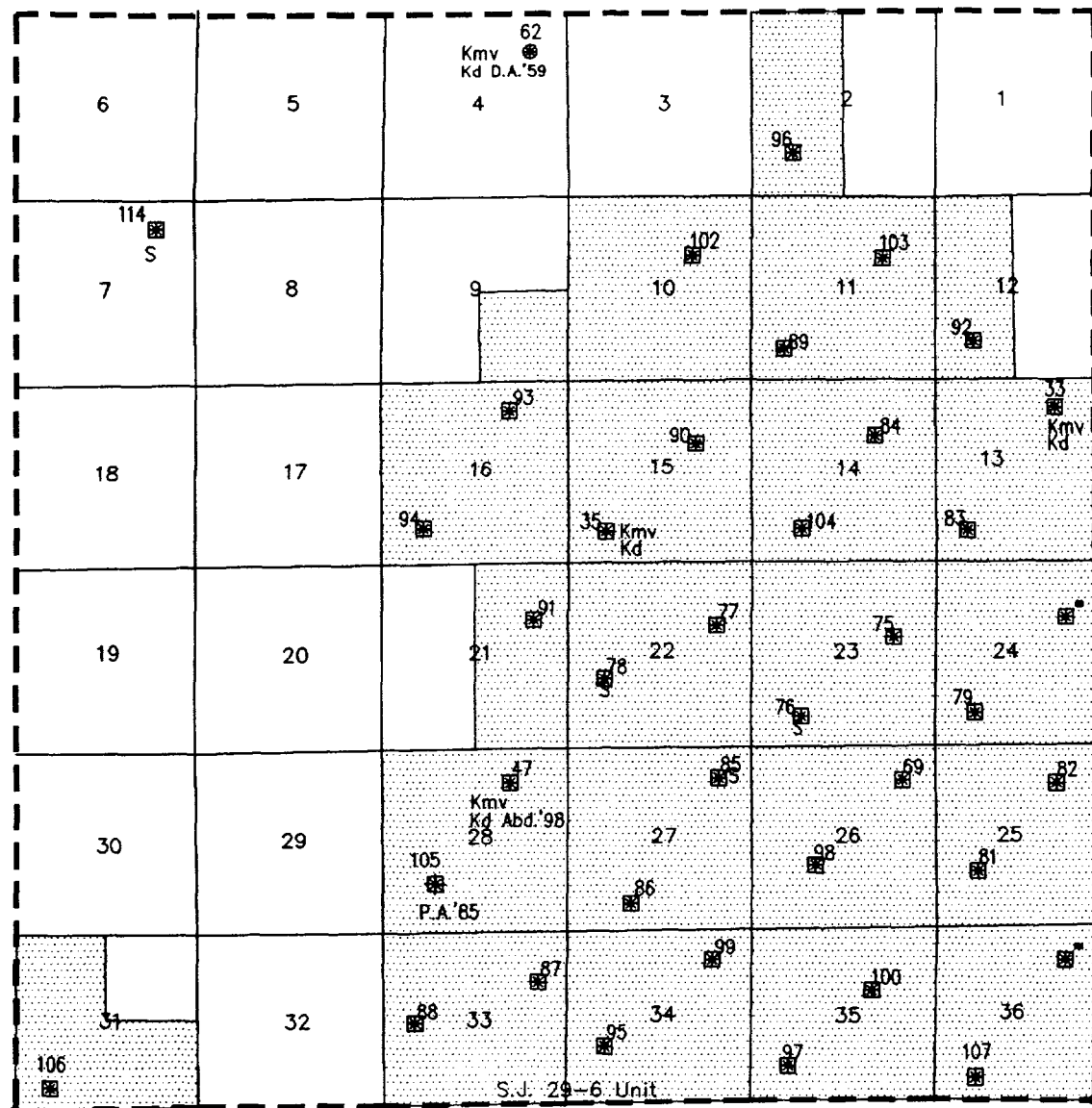
