

AMENDED APPLICATION

KCS Medallion Resources, Inc. applies for simultaneous dedication in the Morrow formation underlying the W $\frac{1}{2}$ of Section 27, Township 18 South, Range 31 East, N.M.P.M., Eddy County, New Mexico, and for an unorthodox gas well location, and in support thereof, states:


1. Applicant is a working interest owner in the W $\frac{1}{2}$ of said Section 27. The W $\frac{1}{2}$ of Section 27 is currently dedicated to the Greenwood Pre-Grayburg Unit Fed. C Com. Well No. 1, located in the NW $\frac{1}{4}$ SW $\frac{1}{4}$ (Unit L) of Section 27, which is producing from the Morrow formation (Shugart-Morrow Gas Pool). 30-319-

2. Applicant proposes to drill its Shugart Fed. "27" Well No. 1, at an unorthodox gas well location 1202 feet from the North line and 660 feet from the West line (Unit D) of Section 27, to a depth sufficient to test the Morrow formation, and seeks an exception to Division Rule 104.D(3) to permit it to simultaneously dedicate the W $\frac{1}{2}$ of Section 27 to both the existing and proposed wells. 1980S & 660W

3. The granting of this application will prevent waste and protect correlative rights.

WHEREFORE, applicant requests that, after notice and hearing, the Division grant the relief requested above.

"27" Well No. 1 to the base of the Morrow formation at a location 1202 feet from the North line and 660 feet from the West line (Unit D) of Section 27, Township 18 South, Range 31 East, NMPM, said location being unorthodox for the Shugart-Morrow Gas Pool. Applicant also seeks to dedicate the W½ of Section 27 to the proposed well and to the existing Greenwood Pre-Grayburg Unit Fed. C Com. Well No. 1, located in Unit L of Section 27. Said unit is located approximately 10 miles southeast of Loco Hills, New Mexico.
