Arriba County, New Mexico, forming standard 320 acre spacing and proration units respectively. Said units are to be dedicated to applicant's Carson No. 5 well which is to be drilled at an unorthodox well location in Unit B of said Section 30. Applicant also seeks approval to dedicate the pooled units to its Carson No. 5-M infill well to be drilled at an orthodox infill location in unit P of said Section 30, following the completion of the Carson No. 5 well.
