APPLICANT

The West Lovington-Strawn Pool was unitized effective October 1, 1995, and expanded on November 1, 1997. A pressure maintenance project was successfully instituted in the unitized Strawn interval. A second expansion of the unit is now proposed, to include substantial additional acreage and two more Strawn wells.

There is general agreement between interest owners on a number of issues. There are also areas of disagreement. Gillespie Oil, Inc., on behalf of the Technical Committee, has proposed expansion as set forth in the application filed herein. In addition, Charles B.
