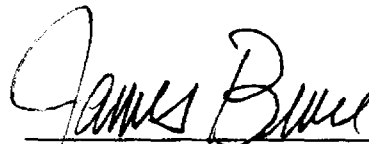

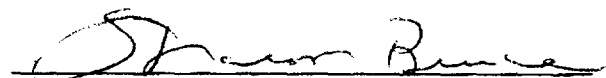

Ladies and Gentlemen:

You previously received notice of an application for administrative approval of an unorthodox gas well location, filed with the New Mexico Oil Conservation Division by Nearburg Exploration Company, L.L.C. ("Nearburg"), regarding its proposed Sagebrush "24" Fed. Com. Well No. 1, located 660 feet from the North line and 990 feet from the East line of Section 24, Township 19 South, Range 33 East, NMPM, Lea County, New Mexico. The well will be drilled to test the Morrow formation, and the E½ of Section 24 will be dedicated to the well. Due to an objection by an offset interest owner, the application will be scheduled for hearing before the Division. Nearburg will request that the application be heard at 8:15 a.m. on Thursday, June 24, 1999 at the Division's offices at 2040 South Pacheco Street, Santa Fe, New Mexico 87505, in conjunction with a compulsory pooling hearing on the well unit scheduled for that date.
