On the sixth day of December, 1999, Order No. R-11292 was entered by the Division, for the forced pooling of all interests under the E/2 of Section 28, Township 23 South, Range 29 East, NMPM, Eddy County, New Mexico. The only other interest owner other than Prairie Sun, Inc. was Exxon Corporation. The order requires that the operations on the well commence on or before March 10, 2000.

Since the entry of the order, Prairie Sun has been contacted by VF Petroleum of Midland, Texas, and they have advised that they have arranged a farm out agreement with Exxon, though the formal paperwork has not been received.
