Dear Mr. Hurlbut:

Following Enron Oil & Gas Company's (now EOG Resources, Inc.) ("EOG") well proposal of August 27, 1999, please be advised that due to a playa lake, the location has been moved to 660' FSL and 660' FEL of this Section 4. The drilling of this Amtrak State Com. No. 1 well as a 10,200' Morrow test remains with the E/2 Section 4-T17S-R28E, Eddy County New Mexico as the proposed spacing unit. Although this is considered a Lower Morrow test, this total depth actually bottoms the well in the top of the Mississippian Chester formation.

In this regard please find (2) copies of EOG's AFE for this test. Should you elect to participate, please execute and return one (1) AFE. An Operating Agreement will be forwarded upon such election.

Should you elect not to participate, EOG would be willing to enter into a mutually agreeable trade for the drilling of this well.

Also, as you are likely aware, Chi Energy, Inc. has proposed a similar well albeit at a location in the SW/4 and with the S/2 of this Section 4 as the spacing unit. Today EOG received a compulsory pooling application for their location and spacing unit. Although EOG would prefer to enter into mutual trades, EOG is forced to file its own compulsory pooling hearing to protect its interests. Even though your company will soon receive this application, EOG is still hopeful of entering into voluntary agreements.





Enron proposes to dedicate the referenced pooled unit to its Amtrak State Com Well No. 1 to be drilled at a standard location 660 feet from the South line and East lines of said Section 4.

This application has been set for hearing before a Division Examiner on October 7, 1999. You are not required to attend this hearing, but as an owner of an interest that may be affected by this application, you may appear and present testimony. 
