#### STATEMENT OF CASE

#### **APPLICANT**

Applicant seeks an order pooling all mineral interests from the surface to the base of the Wolfcamp formation underlying the SE/4 NE/4 for all formations developed on 40-acre spacing, Section 29, Township 15 South, Range 36 East. Applicant proposes to dedicate this pooled unit to its Prince Nymph Well No. 1-A which will be drilled by re-entering the Prince-Nymph Well No. 1 located 2308 feet from the South line and 943 feet from the East line in Unit 1 of Section 29 and kicking off and directionally drilling in a northerly direction to an unorthodox bottomhole location within 50 feet of a point 2440 feet from the North line and 866 feet from the East line in Unit H of Section 29 provided, however, the bottomhole location shall not be closer than 200 feet to the southern boundary of the dedicated 40-acre spacing unit. Also to be considered will be the costs of drilling and completing the well and the allocation of the cost thereof, as well as actual operating costs and charges for supervision, designation of applicant as operator of the well, and a charge for risk involved in drilling and completing the well. The unit is located approximately 2 miles northeast of Lovington, New Mexico.
