Recently many questions and concerns have arisen concerning the status, ownership and operatorship of the three (3) captioned wells. Much of the confusion centers on the proposed recompletion of the Atlantic Com "A" #7, by Mr. G. T. McAlpin under cover dated September 3, 1992, and the drilling of the Atlantic Com "A" #7R, by Meridian in May 1991. In an effort to clarify the situation, I will briefly review the status, working interest ownership, and governing agreements of each of the three wells.

Governing Agreements:

- Meridian originally proposed the well in February 1990, to all Working Interest Owners, and offered all parties (even GLA-46) the opportunity to participate in drilling and completion.
- 87.50% W.I. subject to this JOA dated November 1, 1976.
- 12.50% W.I. subject to GLA-46.
- The well was deferred by Meridian in 1990, and reproposed to all parties in May 1991, at which time we recommended that all parties enter a Modern Form JOA providing for a 100/300/300 non-consent penalty. This proposal was not agreeable to the Working Interest Owners, so Meridian proceeded to drill the well under the two governing agreements and carried a total 24.681282% non-consent. Meridian did not offer a proportionate share of the non-consent interest to all participating parties because of the onerous nature of GLA-46, and the cumbersome accounting involved.

Currently, all three Mesaverde wells in the E/2 Section 23, T31N-R10W are producing in paying quantities and sharing the single proration unit allowable. Meridian opposes the rework of the Atlantic Com "A" #7, proposed by Mr. McAlpin because it is not to the benefit of the majority of the working interest ownership due to allowable constraints.
