1	WHEREUPON, the following proceedings were had at
2	9:00 a.m.:
3	CHAIRMAN WROTENBERY: This is the Commission
4	hearing on Friday, July 21st, 2000. We're here in the OCD
5	hearing room in Santa Fe, New Mexico. It's about 9:00 a.m.
6	We have Commissioner Lee participating by
7	telephone this morning, because we've got a very short
8	agenda and didn't see a need for him to make the trip all
9	the way to Santa Fe for just the two items that or three
10	items, I guess, that we've got on the agenda today. We
11	also have in person Commissioner Bailey, representing Land
12	Commissioner Ray Powell. And I'm Lori Wrotenbery, Chairman
13	of the Oil Conservation Commission.
14	We've got just a few items that I think we'll
15	just go ahead and get through quickly here.
16	One is the minutes of the hearing of the Oil
17	Conservation Commission held on June 23rd, 2000.
18	Commissioners, I believe you've had a chance to review a
19	draft of these minutes?
20	COMMISSIONER BAILEY: Yes, I have, and I move
21	that we adopt them.
22	COMMISSIONER LEE: Second.
23	CHAIRMAN WROTENBERY: All in favor say "aye".
24	COMMISSIONER BAILEY: Aye.
25	COMMISSIONER LEE: Aye.

1	CHAIRMAN WROTENBERY: Aye. And I'll sign on
2	behalf of the Commission.
3	* * *

5	CHAIRMAN WROTENBERY: And then we had a few other
6	cases that were advertised on the docket, but these have
7	either been continued or dismissed. Let me just go through
8	those quickly.
9	We had Case 12,008. This is the Application of
10	Robert E. Landreth for a determination of reasonable well
11	costs in Lea County, New Mexico. This case has been
12	continued to the Commission's hearing on August 23rd, 2000,
13	at the request of the Applicant.
14	We also had Case 12,325, the Application of
15	Chesapeake Operating, Inc., for compulsory pooling and an
16	unorthodox subsurface location in Lea County, New Mexico.
17	This particular case will be continued to the Commission
18	hearing on August 23rd, 2000.
19	We have, Commissioners, received a letter from
20	the parties with a proposed settlement agreement, and in
21	the time intervening between this meeting and the next,
22	Steve Ross will incorporate the provisions of this
23	agreement into a draft order and circulate it to your for
24	your consideration, and then we can take action on that
25	order at the August meeting.

1	We had also Case 12,289, the Application of
2	Gillespie Oil, Inc., and Energen Resources Corporation to
3	amend Division Order Number R-10,864-A for unit expansion,
4	statutory unitization and qualification of the expanded
5	unit area for the recovered oil tax rate and certification
6	of a positive production response pursuant to the "New
7	Mexico Enhanced Oil Recovery Act", Lea County, New Mexico.
8	And this case has been dismissed at the request of the de
9	novo Applicants, Snyder Ranches, Inc., and Larry Squires,
10	Inc. I have sent the parties a letter concerning the
11	dismissal.
12	* * *
13	
14	CHAIRMAN WROTENBERY: I believe that was
15	everything except for the one case we do want to finish up
16	today. This is the Application of Redwolf Production,
17	Inc., for compulsory pooling in San Juan County, New
18	Mexico.
19	The Commission took evidence in this case at the
20	Commission hearing last month. We also deliberated on the
21	case at that time. Since then, Mr. Ross has circulated a
22	draft order in the case. Commissioners, have you had a
23	chance to review the language of the draft order?
24	COMMISSIONER BAILEY: Yes, I have, and the
25	correction that was made to it yesterday.

CHAIRMAN WROTENBERY: Okay, great. Commissioner 1 Lee? 2 COMMISSIONER LEE: Yes, I have read it. I have 3 no problem with it. 4 Okay. I'm not sure, Mr. 5 CHAIRMAN WROTENBERY: Ross, did Commissioner Lee have a chance to look at the one 6 7 change that was made in the order? MR. ROSS: No, that was just made a few minutes 8 9 ago. 10 CHAIRMAN WROTENBERY: Okay, would you please 11 describe that particular change for Commissioner Lee? Do 12 you need this? 13 MR. ROSS: Commissioner Lee, in paragraph 6 of the order --14 15 COMMISSIONER LEE: Just a second, let me double-16 check. 17 MR. ROSS: -- and that would be on page 2. 18 COMMISSIONER LEE: Let me pull it up. Okay. 19 MR. ROSS: We just added the words, "and a lessee 20 of record" in that paragraph. So it now reads, "The 21 Applicant is a working interest owner and a lessee of 22 record within the subject proration unit." 23 COMMISSIONER LEE: I have no problem with that. 24 CHAIRMAN WROTENBERY: Do we need to discuss this 25 particular order any further?

COMMISSIONER BAILEY: No, I move that we sign it. 1 2 COMMISSIONER LEE: I second. CHAIRMAN WROTENBERY: Okay. And let me just 3 clarify. The motion is to sign the order with the change 4 in Finding Paragraph Number 6 that Mr. Ross just read into 5 the record? 6 7 COMMISSIONER BAILEY: Yes, that's right. 8 CHAIRMAN WROTENBERY: Well, then, all in favor say "aye". 9 10 COMMISSIONER BAILEY: Aye. 11 COMMISSIONER LEE: Aye. 12 CHAIRMAN WROTENBERY: Aye. Great, let's sign the 13 order. 14 Commissioner Lee, we'll send the order to you for your signature by mail. You've got your pen with you down 15 16 there? 17 COMMISSIONER LEE: I've a pen with -- for real. 18 CHAIRMAN WROTENBERY: Oh, well we may have send 19 the order with your pen. 20 Okay. And then Mr. Ross has some pending and prospective litigation that he needs to brief the 21 Commission on, so I will entertain a motion that we go into 22 23 closed session for a few minutes to discuss those matters. 24 COMMISSIONER BAILEY: I so move. 25 COMMISSIONER LEE: Second.

Okay. We have 16 finished our deliberations on pending and prospective 17 litigation. I just note for the record that that is all that we discussed while we were in closed session. 18 19 And at this point I don't believe we have any 20 other items on our agenda.
