- 5. All documents, including but not limited to reserve projections, corresponding pressure data, geological studies, and production data which you contend support your request for unorthodox location and/or simultaneous dedication

whereby more than one well occupies a gas proration unit in the Jalmat Gas Pool.

- 6. All documents, including but not limited to (a) land files, (b) transfers of interest, assignments of interest, and Assignments and Bill of Sale in the subject wells, or of acreage on which the subject wells are located, from or to SDX and any other party, (c) transfers of interest, assignments of interest, and Assignments and Bill of Sale in the subject wells, or of acreage on which the subject wells are located, from SDX natural Gas Partners, LLC, to any other party, (d) lists of interest owners in the acreage comprising proration units for the subject wells, and (e) all communications to or from SDX related to any transfer of interest and the administrative applications for the subject wells.
- 7. All documents referencing any communication between you and the New Mexico Oil Conservation Division, its Director, hearing officers, agents, and employees, including but not limited to meeting notes, expense account statements, telephone message slips, memoranda, correspondence, regarding the Subject Wells and/or your infill drilling program for the Jalmat Gas Pool in Lea County, New Mexico.
