The purpose of this supplemental notice is to advise you that:

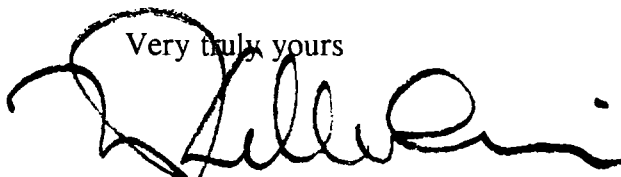
(a) the original application incorrectly described the pool as either the "South Los Pinos-Pictured Cliffs Gas Pool" or the "South Pinos-Pictured Cliffs Gas Pool" when in fact the correct name is the "South Los Pinos Fruitland Sand-Pictured Cliffs Pool"; and

(b) the case was heard on March 16, 2000 but continued to 8:15 AM on April 20, 2000 in order to correct the description for this pool and to provide you with an additional opportunity to object to this application. The hearing will be held at the Division hearing room located at 2040 S. Pacheco, Santa Fe, New Mexico.

As an interest owner who may be affected by this application, we are notifying you of your right to appear at the hearing and participate in this case, including the right to present evidence either in support of or in opposition to the application. Failure to appear at the hearing may preclude you from any involvement in this case at a later date.

Pursuant to the Division's Memorandum 2-90, you are further notified that if you desire to appear in this case, then you are requested to file a Pre-Hearing Statement with the Division not later than 4:00 PM on Friday, April 14, 2000, with a copy delivered to the undersigned.

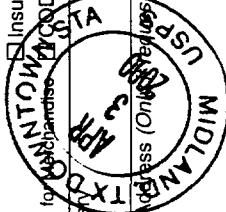

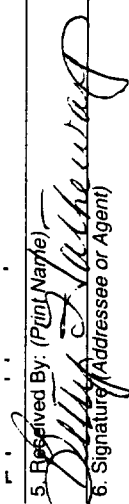
