
Reference is made to Santa Fe Snyder Corporation's (Santa Fe's) letter dated December 9, 1999 proposing to drill the referenced well as a 13,700' Morrow test at a location 1,980' FNL & 660' FWL of Section 17, T-23-S, R-34-E, Lea County, New Mexico.

As an alternative to your participation in the proposed well, Santa Fe hereby offers to purchase all of Southwestern Energy Production Company's (SWEPCO's) interest in the N/2 of said Section 17 for \$20,000.00 total bonus consideration (\$125.00 per net acre) subject to SWEPCO's reservation of a proportionately reducible Overriding Royalty interest equal to the difference by which 20% exceeds existing lease burdens.

This offer shall remain in effect until 5:00 P.M. CST on February 29, 2000, after which it may be withdrawn at Santa Fe's option without notice. To indicate your acceptance of this proposal, please execute and return to the undersigned one copy of this letter.
