<u>DOCUMENTS TO BE PRODUCED</u>: All documents, records, and data in your possession or under your control regarding the matters itemized below:

- 1. Core Hole MTE-183, located in the SW\(\frac{1}{2}\)SW\(\frac{1}{2}\) of Section 35, Township 21 South, Range 31 East, N.M.P.M.
- 2. Core Hole MTE-185, located in the SW¼SE¼ cf Section 26, Township 21 South, Range 31 East, N.M.P.M.
- 3. Core Hole MTE-188, located in the SE¼NW¼ of Section 2, Township 22 South, Range 31 East, N.M.P.M.
- 4. The extent and location of your Life of Mine Reserves ("LMR") boundary in Section 35, Township 21 South, Range 31

- East, N.M.P.M., and Sections 1, 2, and 3, Township 22 South, Range 31 East, N.M.P.M.
- 5. A plat or other information which shows or will reveal the current extent of your mine workings in Township 21 South, Range 31 East, N.M.P.M.
- 6. Current, existing State of New Mexico potash or potassium leases covering Sections 25-27 and 34-36, Township 21 South, Range 31 East, N.M.P.M., and Sections 1-3, Township 22 South, Range 31 East, N.M.P.M., including the name of the lessee, the date of the lease, the dates the lease was signed by you and the Commissioner of Public Lands, and the royalty rate on each lease.
- 7. The type(s) and grades of potassium ore which you (i) are currently mining, and (ii) have mined over the past two years.
