**Re:** Oil Conservation Division Case No. 12415: Application of Nearburg Exploration Company, L.L.C. for compulsory pooling, Eddy County, New Mexico.

Dear Ms. Wrotenbery;

On June 7, 2000, the Division entered Order No. R-11393 which granted the application of Nearburg Exploration Company, L.L.C. in the above-referenced case pooling all mineral interests from the surface to the base of the Morrow formation under the following spacing and proration units in Section 29, Township 18 South, Range 37 East, NMPM, Lea County, New Mexico:

- A. E/2 to form a standard 320-acre spacing and proration unit for all formations and/or pools developed on 320-acre spacing;
- B. NE/4 to form a standard 160-acre spacing and proration unit for all formations and/or pools developed on 160-acre spacing;
- C. E/2 NE/4 to form an 80-acre spacing and proration unit for all formations and/or pools developed on 160-acre spacing; and

D. SE/4 NE/4 to form a standard 40-acre oil spacing and proration unit for all formations and/or pools developed on 40-acre spacing.

These pooled units are to be dedicated to the Pathfinder "29" State Com Well No. 1 which Nearburg proposes to drill at a standard location in the E/2 of Section 29.

Order R-11393 provides that in the event Nearburg does not commence drilling operations on or before September 9, 2000, this pooling order shall be of no further effect unless Nearburg obtains a time extension from the Division Director for good cause shown. The purpose of this letter is to request a 90-day extension of Order No. R-11393.

Nearburg intends to drill the Pathfinder "29' State Com Well No. 1 in the E/2 of Section 29. However, there is off-set development in the area and Nearburg will not be able to determine the exact location necessary to most effectively enable it to recover the reserves under the subject acreage until it receives and reviews the information from these wells. An extension of Order No. R-11393 from September 9, 2000 to December 9, 2000 is therefore needed. Your attention to this request is appreciated.
