YATES PETROLEUM CORPORATION ("Yates"), through its undersigned attorneys, hereby makes application to the Oil Conservation Division for an order approving an unorthodox well location, and in support of this application states:

- 1. Yates is a working interest owner in the W/2 of Section 8, Township 25 South, Range 26 East, N.M.P.M., Eddy County, New Mexico, and proposes to drill its Chosa "ATR" Federal Well No. 1 (API No. 30-015-31215) to the Morrow formation, Undesignated Chosa Draw-Morrow Gas Pool, to an approximate depth of 12,000 feet, at an unorthodox gas well location 2250 feet from the South line and 1060 feet from the West line of said Section 8.
- 2. Yates originally proposed to drill this well at a standard location but has had to move the well to an unorthodox location because of the Black River to the south, a cave to the northwest, and archeological sites to the west and south of the original proposed location. Accordingly, Yates seeks an exception to Rule 104 C(2)(a) of the General Rules and Regulations of the Oil Conservation Division to permit the drilling of this well at this unorthodox gas well location.

3. A standard spacing unit comprised of the W/2 of Section 8 will be dedicated

to the well.

4. Approval of this application will afford the interest owners in this spacing unit

the opportunity to produce their just and equitable share of the reserves under the subject

unit and will otherwise be in the best interest of conservation, the prevention of waste and

the protection of correlative rights.

WHEREFORE, Yates Petroleum Corporation requests that this application be set for

hearing before an Examiner of the Oil Conservation Division on October 5, 2000, that notice

be given as required by law and the rules of the Division, and that the Division enter its

order granting this application.
