

EOG RESOURCES, INC. ("EOG"), through its undersigned attorneys, hereby makes application to the Oil Conservation Division for an order approving an unorthodox well location, and in support of this application states:

1. Applicant is a working interest owner in W/2 of Section 22, Township 16 South, Range 29 East, N.M.P.M., Eddy County, New Mexico, and proposes to drill its Conoco "22" Federal Com Well No. 1 as a wildcat well through the top 100 feet of the Mississippian Chester formation, at an unorthodox gas well location 2310 feet from the North line and 1427 feet from the West line of said Section 22.

2. Applicant seeks an exception to Rule 104C(2)(a) of the General Rules and Regulations of the Oil Conservation Division to permit the drilling of this well at this unorthodox gas well location.

3. The W/2 of Section 22 should be dedicated to the well.


4. Approval of this application will afford the interest owners in this spacing and proration unit the opportunity to produce their just and equitable share of the reserves under the subject spacing and proration unit and will otherwise be in the best interest of

conservation, the prevention of waste and the protection of correlative rights.
