Applicant seeks an order pooling all mineral interests in all formations developed on 320-acre spacing from the surface to the base of the Wolfcamp formation in the N/2 of Section 28, Township 24 South, Range 33 East, in the following manner: the N/2 for all formations/pools developed on 320-acre spacing which includes but is not necessarily limited to the Undesignated Johnson Ranch-Wolfcamp Gas Pool and the Undesignated East Triste Draw-Wolfcamp Pool, the NW/4 for all formations/pools developed on 160-acre spacing, and the NE/4 NW/4 for all formations/pools developed on 40-acre spacing which includes but is not necessarily limited to the Undesignated East Triste Draw-Bone Spring Pool and the Undesignated Triste Draw-Delaware Pool. Said units are to be dedicated to the State Com Well No. 1 to be drilled at a standard location in the NE/4 NW/4 of Section 28. Also to be considered will be the cost of drilling and completing said well and the allocation of the cost thereof as well as actual operating costs and charges for supervision, designation of applicant as operator of the well and a charge for risk involved in drilling said well. Said area is located approximately 8 miles east-southeast of the intersection of Highway 128 with the Eddy-Lea County line.

CASE 12586: ^{9/} ~~26~~ Application of Chevron U.S.A. Production Company for an unorthodox well location, Lea County, New Mexico.

Applicant seeks authorization to recomplate its G. C. Matthews Well No. 12 (API No. 30-025-05953) in the Tub formation, at an unorthodox gas well location 330 feet from the South line and 990 feet from the East line (Unit P) of Section 6, Township 20 South, Range 37 East. The SE/4 of Section 6 is to be dedicated to the well to form a standard 160-acre gas spacing and proration unit for the West Monument-Tubb Gas Pool. This well is located approximately 5 miles northwest of Eunice, New Mexico.

CASE 12587: ^{10/} ~~26~~ Application of Sapient Energy Corp for an unorthodox well location and two non-standard 160-acre spacing units, Lea County, New Mexico.

Applicant seeks approval of an unorthodox gas well location for its Bertha J. Barber Well No 12 ("Barber 12 Well") which is located at an unorthodox gas well location 330 feet from the North line and 660 feet from the East line of Section 7, Township 20 South, Range 37 East, to be dedicated to a non-standard 160-acre gas proration and spacing unit consisting of the E/2 E/2 of this section for production from the West Monument-Tubb Gas Pool retroactive to the date of first production (September 9, 1999). In addition, applicant seeks the approval of a second non-standard 160-acre proration and spacing unit consisting of the W/2 E/2 of this section.

CASE 12559: ^{11/} ~~26~~ (REOPENED AND READVERTISED) Application of Trilogy Operating, Inc. for compulsory pooling, Lea County, New Mexico.

Applicant, in accordance with Division Rule 1207.A(1)(b) seeks an order pooling all mineral interests from the surface to the base of the Abo formation underlying the SW/4 SE/4 of Section 1, Township 20 South, Range 38 East, forming a standard 40-acre oil spacing and proration unit for any and all formations and/or pools spaced on 40-acre spacing, including but not limited to the Undesignated House-San Andres Pool, House-Blinbry Pool, East Warren-Tubb Oil and Gas Pool and Undesignated D-K-Abo Pool. This unit is to be dedicated to its Howser Well No. 2 being drilled at a standard well location in Unit O of this section. Also to be considered will be the costs of drilling and completing the well and the allocation of the costs thereof as well as actual operating costs
