
Ladies and Gentlemen:

This letter is to advise you that David H. Arrington Oil and Gas, Inc. has filed the enclosed application with the New Mexico Oil Conservation Division seeking approval of an unorthodox gas well location Mayfly "14" State Com. Well No. 4 to be re-completed in the Morrow and Mississippian formations at an unorthodox gas well location 1651 feet from the North line and 371 feet from the West line of said Section 14. The W/2 of said Section 14 is to be dedicated to the well.

This application has been set for hearing before a Division Examiner on March 8, 2001. You are not required to attend this hearing, but as an owner of an interest that may be affected by this application, you may appear and present testimony. Failure to appear at that time and become a party of record will preclude you from challenging the matter at a later date.

Parties appearing in cases are required by Division Rule 1208.B to file a Prehearing Statement three days in advance of a scheduled hearing. This statement must include: the names of the parties and their attorneys; a concise statement of the case; the names of all witnesses the party will call to testify at the hearing; the approximate time the party will need to present its case; and identification of any procedural matters that are to be resolved prior to the hearing.

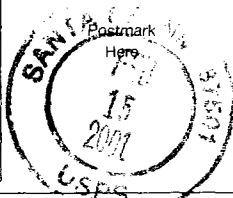
