

The New Mexico Environment Department would like to receive public comment on the designation of the County of Dona Ana as a managerial agency for wastewater treatment and disposal in the County of Dona Ana. Designation as a management agency is a prerequisite for eligibility for construction funding under 603 (f) of the Federal Clean Water Act.

The Department will present its recommendation to the Water Quality Control Commission on May 8, 2001. The meeting will be at the Roundhouse in room 317 at 9:00 am. This recommendation will be in the form of a proposed update to Work Element 13, Designation of Management Agencies of the Statewide Water Quality Management Plan to identify/approve the appropriate management agency for the area under consideration.

#### NOTICE OF PUBLIC HEARING

The New Mexico Environment Department will hold a public hearing to consider proposed changes to 20 NMAC 1.4 — Environment Department Permit Procedures. The hearing will take place on May 4, 2001, at 10:00 a.m. in the State Capitol Building, Room 326, corner of Paseo de Peralta and Old Santa Fe Trail, Santa Fe, New Mexico.

The proponent of the regulatory change is the New Mexico Environment Department (NMED). NMED proposes to make minor revisions to its permitting procedures, 20 NMAC 1.4, to delete references to the Water Quality Act and the Water Quality Control Commission. The reason for these revisions is that the NMED rules conflict in certain respects with similar rules issued by the Water Quality Control Commission, resulting in considerable confusion, within NMED, the regulated community, and the general public, as to which rules should apply. The hearing will be conducted in accordance with the Department of Environment Act, NMSA 1978 § 9-7A-6, and the procedurarules in 20 NMAC 1.1.400-405 will be used as guidance.

All interested persons will be given an opportunity at the hearing to submit relevant evidence, data, views, and arguments, orally or in writing, to introduce exhibits, and to examine witnesses. Persons desiring to present technical testimony must file a written notice of intent on or before April 24, 2001. The notice of intent shall:

- identify the party for whom the witness will testify;
- identify each technical witness the party intends to present and state the qualifications of that witness, including a description of their educational and work background;
- summarize or include a copy of the direct testimony of each technical witness and state the anticipated duration of the testimony;
- include the text of any recommended modifications to the proposed regulatory change; and
- list and describe, or attach, all exhibits anticipated to be offered by that person at the hearing.

Notices of intent must be filed in the office of the Hearing Clerk and should state the date and title of the hearing. Any person who wishes to submit a <u>non-technical</u> written statement in lieu of oral testimony may do so at or before the hearing.
