
Ladies and Gentlemen:

This letter is to advise you that EOG Resources, Inc. has filed the enclosed application with the New Mexico Oil Conservation Division seeking the creation of a new pool as the result of the discovery of hydrocarbons in the Strawn formation in its Oak Lake "25" Federal Well No. 1 located 850 feet from the North line and 750 feet from the West line of Section 25, Township 17 South, Range 30 East, NMPM, Eddy County, New Mexico. EOG also seeks the approval of a discovery allowable for this well and the promulgation of special pool rules and regulations for the pool, including 160-acre spacing and proration units, special well location requirements, a special gas-oil ratio of 4,000 cubic feet of gas for each barrel of oil produced, and a special depth bracket allowable for the pool. This pool will be located in the NW/4 of said Section 24.

This application has been set for hearing before a Division Examiner on May 3, 2001. You are not required to attend this hearing, but as an owner of an interest that may be affected by this application, you may appear and present testimony. Failure to appear at that time and become a party of record will preclude you from challenging the matter at a later date.

Parties appearing in cases are required by Division Rule 1208.B to file a Prehearing Statement three days in advance of a scheduled hearing. This statement must include: the names of the parties and their attorneys; a concise statement of the case; the names of all witnesses the party will call to testify at the hearing; the approximate time the party will need to present its case; and identification of any procedural matters that are to be resolved prior to the hearing.
