3 EXAMINER CATANACH: At this time I'll call Case
4 12,678, which is the amended Application of Raptor
5 Resources, Inc., for two unorthodox infill gas well
6 locations and simultaneous dedication, Lea County, New
7 Mexico.

8 Call for appearances in this case.

9 MR. CARR: May it please the Examiner, my name is
10 William F. Carr with the Santa Fe law firm Holland and
11 Hart, L.L.P. We represent Raptor Resources, Inc., in this
12 matter.

13 Mr. Examiner, as you will recall, this case was
14 heard on June the 14th, and at that time it was discovered
15 that certain wells on the subject unit had been omitted
16 from the Application and advertisement. We presented
17 testimony that covered all wells on that date and were
18 given permission to file an amended Application and
19 renotify all affected parties with the case to be reopened
20 today.

21 We filed the amended Application, and I have an
22 affidavit confirming that all parties have been notified in
23 accordance with Division rules, and we would ask permission
24 to admit Raptor Exhibit A, which is the notice affidavit,
25 and request that the case be taken under advisement based

1 on the June 14th record.

2 EXAMINER CATANACH: Okay, Mr. Carr, Exhibit A
3 will be admitted in Case Number 12,678.

4 MR. CARR: And that concludes our presentation in
5 this matter.

6 EXAMINER CATANACH: And just let the record show
7 that there are no other parties present in the room to
8 appear in this case. And there being nothing further, Case
9 12,678 will be taken under advisement.


