APPLICANT

Applicant seeks an order pooling all mineral interests in the Wolfcamp formation
underlying the SE/4 of Section 7, Township 16 South, Range 36 East, NMPM, to form a
standard 160-acre spacing and proration unit for production from the North Shoe Bar
Wolfcamp Oil Pool. Said unit is to be dedicated to Applicant's Chambers No. 2 well to
be drilled from a standard location in the N/2 SE/4 of said Section 7 to a depth sufficient

to test the Wolfcamp formation in the pooled interval, as well as the Strawn formation, North Shoe Bar Strawn Oil Pool. Also to be considered will be the cost of drilling and completing said well and the allocation of the cost thereof, as well as actual operating costs and charges for supervision, designation of Applicant as operator and a charge for the risk involved in drilling said well. The subject lands are located approximately 4 miles east of Lovington, New Mexico.
