

Dear Ms. Wrotenbery:

Leonard Resource Investment Corporation ("Leonard Resource") requests that the well commencement deadline be extended for 90 days. The reasons for this request is as follows:

1. The above order grants Leonard Resource until January 31, 2002 to commence the well.
2. Leonard Resource recently completed and connected to a pipeline the following offsetting wells:
  - (a) The Red Tag Well No. 1, in the NW $\frac{1}{4}$ SE $\frac{1}{4}$  of Section 2, was drilled to a depth of 7839 feet early this year. Completion was attempted in the Abo, Drinkard, Tubb, and Blinebry, with poor results. Daily production from the well in November averaged approximately 12 BO and 30 MCFG. The operator has proposed to re-stimulate the Blinebry, provided the Red Tag Well No. 2 is successfully completed in that interval; and
  - (b) The Red Tag Well No. 2, in the NE $\frac{1}{4}$ SW $\frac{1}{4}$  of Section 2, was drilled to a depth of 7790 feet in August 2001. The well was completed in the Abo on October 31st, commingled with the Drinkard early in December, and placed on pump on December 11th.


Due to the nature of wells in this area, approximately 2-3 months is needed to evaluate production to determine

whether they are commercial, and to decide whether to drill an offset.

As a result of the foregoing, Leonard Resource requests that the commencement deadline be extended to April 30, 2002.
