(a) CREATE a new pool in Chaves County, New Mexico classified as a gas pool for Atoka production and designated as the Broke Tank Lake-Atoka Gas Pool. The discovery well is the Nadel & Gussman Permian LLC Moon Company Trust Well No. 1 located in Unit N of Section 25, Township 8 South, Range 29 East, NMPM. Said pool would comprise:
