STATEMENT OF THE CASE

APPLICANT

Applicant seeks an order, pursuant to Division Rule 303.B, approving surface commingling of Blanco-Mesaverde Gas Pool production from its Armenta Gas Com. C Well No. 1A, located in the N $\frac{1}{2}$ of Section 27, Township 29 North, Range 10 West, NMPM, with Basin-Fruitland Coal Gas Pool production from its Armenta Gas Com. G Well No. 1, located in the E $\frac{1}{2}$ of Section 27, Township 29 North, Range 10 West, NMPM.

Evidence supporting the application was presented at the March 7th Examiner hearing, but the case was continued by the Division so that applicant's representatives could meet and discuss the proposal with Mr. Armenta. Applicant will present testimony of its numerous contacts with Mr. Armenta, and that his concerns do not relate to the merits of surface commingling.


