**CASE 12895:** In the matter of the hearing called by the Oil Conservation Division for an order creating, contracting, and extending certain pools in Chaves and Eddy Counties, New Mexico.

(a) CREATE a new pool in Eddy County, New Mexico classified as a gas pool for Atoka production and designated as the Revelation-Atoka Gas Pool (pool code 97205). The discovery well is the Yates Petroleum Corporation Whopper “AZD” State Well No. 2 located in Unit M of Section 2, Township 22 South, Range 25 East, NMPM. Said pool would comprise:

(g) EXTEND the South Empire-Wolfcamp Pool in Eddy County, New Mexico to include:

Section 36: NW/4 and W/2 NE/4

(h) EXTEND the Foor Ranch-Pre-Permian Gas Pool in Chaves County, New Mexico to include:

TOWNSHIP 10 SOUTH, RANGE 26 EAST, NMPM
