Re: Oil Conservation Division Case No. 12912: Application of Yates Petroleum Corporation for compulsory pooling, Eddy County, New Mexico.

Dear Ms. Wrotenbery;

On October 4, 2002, the Division entered Order No. R-11842 which granted the application of Yates Petroleum Corporation in the above-referenced case pooling all uncommitted interests from the surface to the base of the Morrow formation underlying the certain spacing and proration units in the S/2 of Section 25, Township 21 South, Range 26 East, NMPM, Eddy County, New Mexico. These pooled units are to be dedicated to the Louise AYI Well No. 1 which Yates proposes to drill at a standard gas well location 1630 feet from the South line and 682 feet from the East Line (Unit I) of said Section 25 to test all formations to the base of the Morrow formation.

Order R-11842 provides that in the event Yates does not commence drilling operations on or before January 31, 2003, this pooling order shall be of no effect unless Yates obtains a time extension from the Division Director for good cause. The purpose of this letter is to request a 90-day extension of Order No. R-11842.

Yates intends to drill the Louise AYI Well No. 1 as proposed. However, it has encountered delays in obtaining and scheduling the rig for this well. Yates will be unable to commence drilling prior to the current deadline set by Order No. R-11842. An extension of Order No. R-11842 from January 31, 2003 to April 30, 2003 is therefore needed.
