Re: Oil Conservation Division Case No. 12939: Application of Nearburg Exploration Company, L.L.C. for compulsory pooling and directional drilling, Lea County, New Mexico.

Dear Ms. Wrotenbery;

On October 24, 2002, the Division entered Order No. R-11853 which granted the application of Nearburg Exploration Company, L.L.C. in the above-referenced case pooling all uncommitted interests from the surface to the base of the Strawn formation underlying the S/2 SE/4 of Section 15, Township 17 South, Range 37 East, NMPM, Lea County, New Mexico. This pooled unit is dedicated to the Guernsey "15" Well No. 1Y which Nearburg proposes to re-enter and directionally drill from a surface location 710 feet from the North line and 570 feet from the East Line (Unit A) of Section 22, Township 17 south, Range 37 East, NMPM, to a standard bottomhole location 510 feet from the South line and 660 feet from the East line (Unit P) of Section 15 to test the Strawn formation.

Order R-11853 provides that in the event Nearburg does not commence drilling operations on or before February 1, 2003, this pooling order shall be of no effect unless Nearburg obtains a time extension from the Division Director for good cause shown. The purpose of this letter is to request a 90-day extension of Order No. R-11853.

Nearburg intends to drill the Guernsey "15" Well No. 1Y as proposed. However, it has encountered delays in obtaining and scheduling the rig for this well. Nearburg will be unable to commence drilling prior to the current deadline set by Order No. R-11853. An extension of Order No. R-11853 from February 1, 2003 to May 1, 2003 is therefore needed.
