APPLICATION

Chi Energy, Inc. applies for an order pooling all leasehold record title owners from the base of the Wolfcamp formation to the base of the Morrow formation underlying the S% of Section 32, Township 18 South, Range 31 East, N.M.P.M., Eddy County, New Mexico, and in support thereof, states:

- 1. Applicant is a working interest owner in the S½ of Section 32, and has the right to drill a well thereon.
- 2. Applicant proposes to drill its KC Strip State Com. Well No. 1, at an orthodox gas well location, to a depth sufficient to test the Morrow formation, and seeks to dedicate the S% of Section 32 to form a standard 320 acre gas spacing and proration unit for any and all formations and/or pools developed on 320 acre spacing within that vertical extent, including the Undesignated North Shugart-Atoka Gas Pool and Undesignated Shugart-Morrow Gas Pool.
- 3. Applicant has in good faith sought to obtain the voluntary joinder of all other interest owners in the S% of Section 32 for the purposes set forth herein.
- 4. Although applicant attempted to obtain voluntary agreements from all mineral interest owners to participate in the drilling of the well or to otherwise commit their interests to the well, certain interest owners have failed or refused to join in dedicating their interests. Therefore, applicant seeks an order

pooling all mineral interest owners in the S½ of Section 32, pursuant to NMSA 1978 §70-2-17.

5. The pooling of all mineral interests underlying the S% of Section 32 will prevent the drilling of unnecessary wells, prevent waste, and protect correlative rights.

WHEREFORE, applicant requests that, after notice and hearing,
the Division enter its order:

- A. Pooling all leasehold record title owners in the S% of Section 32 from the base of the Wolfcamp formation to the base of the Morrow formation;
- B. Designating Chi Operating, Inc. as operator of the well; and
- C. Granting such further relief as the Division deems proper.

Applicant requests expedited approval of this application in order to obtain State Land Office approval of a communitization agreement which includes an expiring lease.
