

I have your notice of October 2 addressed to all operators - Hobbs and Momment Fields, in which you advise that a meeting of the operators will be held at the LaFonda Hotel, Santa Fe, at 10:00 a.m., October 21, 1939, unless you hear from a majority of the operators to the contrary.

Since receiving your letter we have talked to several of the operators about this meeting and find that they feel that the operators should have some time to consider the report of the engineering committee before the hearing is held. 


Dear Sir:

The hearing on changes in allocation for the Hobbs and Monument pools is set for 10:00 a.m. October 23, at La Fonda Hotel, in Santa Fe. A number of the representatives of operators in both Hobbs and Monument pools will have to be in Texas during the week in which the Commission contemplate holding this hearing, making it virtually impossible for them to attend the proposed hearing on October 23 in Santa Fe.
