SPECIAL MASTER'S BILL OF SALE

THIS BILL OF SALE made and entered into on this the 1st day of May, 1939, by and between W. G. Ogle, Special Master in Cause No. 11841 in the District Court of San Miguel County, New Mexico, party of the first part, and Iverson Tool Company, a corporation, party of the second part.

W I T N E S S E T H

That the party of the first part as the duly appointed, qualified and acting Special Master in Cause No. 11841 in the District Court of San Miguel County, New Mexico, did give notice as provided by law, and as provided in the Final Judgment of said cause of the sale of the personal property hereinafter described pursuant to said judgment. That pursuant to said notice and at the time and place stated therein the said party of the first part offered for sale at public auction to the highest bidder all of the property hereinafter described and that the highest and best bidder therefor was plaintiff in said cause, Iverson Tool Company, a corporation, which bid the sum of \$3000.00. That all and singular said property was thereupon struck off to party of the second part as the purchaser thereof.

That party of the first part has reported his acts in said capacity to the Court and that the sale so made has been duly and properly confirmed, the Report of Special Master herein approved, and this Bill of Sale approved by the Court and ordered delivered.

NOW THEREFORE, for and in consideration of the premises and for the purpose of carrying out the judgment of the Court and the sale aforesaid, and in consideration of the sum of \$3000.00 paid by party of the second part to party of the first part, the receipt whereof is hereby acknowledged, party of the first part as such Special Master has sold, assigned, transferred and delivered unto the party of the second part and by these presents does sell, assign and transfer unto the said party of the second part all of the right, title and interest of the defendants, Hershfield Oil Development Company and Cabra Springs Oil and Gas Company, and of the intervenor, North American Investment Company, in said cause, and each of them in and to the following described personal property situate in San Miguel County, to-wit:

All of the materials, tools, machinery, equipment and supplies used or employed in the drilling of a well for oil and gas by the defendants in said cause in Section 22, Township 12 North, Range 22 East, N. M. P. M., San Miguel County, New Mexico, said property including, but not being limited to the following enumerated articles, to-wit:

One standard wood rig
One 6000 ft. drilling line
One 5000 ft. sand line
All drill stems, bailers and bits located at said well
One set casing blocks
One set casing elevators
Miscellaneous tool wrenches
One complete jack and circle
One 6 5/8ths inch under-rimmer
All timber acrows and drilling clamps
Two 500 bbl. tanks
Oil and water tanks
One set 6 5/8th inch three-prong grabs
One set 8 inch Wilson elevators
Miscellaneous slip sockets, blind boxes and latch jacks
Two 6 5/8ths inch ~~rope~~
One engine crank shaft
One belt pulley
One wall hook
Three miles of two inch water line
One gasoline engine and water pump
One set hole jars

One complete welding outfit
One 12 x 12 drilling engine
Crane post and Yale chain hoist
One steam boiler
Two boiler feed pumps
One light plant with pipe and fittings
One Fairbank-Morse light plant and lines
1000 ft. one-inch water line.

All pipe and casing located at the well above described, whether on the surfact of the ground or in said well; One Chevrolet Truck Model approximately 1933; All camp houses and furnishings therein used in connection with the drilling of said well; Two airplane hangers,

Together with the right to go upon the lands on which the property above described is situate and to reduce the same to possession and to remove same therefrom, and to take all necessary steps incident to obtaining the possession and removal of all of said property and the full benefits incident to the ownership thereof, all as provided by the Court in its judgment and order in said cause.

TO HAVE AND TO HOLD all and singular the above described property and the rights incident thereto unto the said party of the second part, its successors and assigns forever.
