Re: Application for Hearing to Amend Oil Conservation Commission of The State of New Mexico Order No. R-1073-A, So As to Substitute the Capacity Allowable which was granted Graridge Malco State "A" Well #2 to Graridge Malco State "A" Well #9, and Request for Emergency Allowable for Graridge Malco State "A" Well #9 During the Interim

Gentlemen:

On February 18, 1958, the above referred to application was filed with your office relative to the substitution of allowables from the Graridge Malco State "A" Well No. 2 to the Graridge Malco State "A" Well No. 9. In such application the two wells were located by showing the distance from the 40-acre tract involved rather than from the section line. The purpose of this letter is to describe the locations of the two wells from the section lines, which are as follows:

(1) The Graridge Malco State "A" Well No. 2 is located 1650 feet from the East line and 1650 feet from the North line of Section 31, T12S, R32E.

(2) The Graridge Malco State "A" Well No. 9 is located 1650 feet from the East line and 2310 feet from the North line of Section 31, T12S, R32E.

I trust that you will take this letter as authority to substitute the locations as described herein for the ones shown in the application for all purposes of publication and/or hearing.

Gentlemen:

By your orders No. R-1073 and supplements thereto, you have approved a water flood project in the North Caprock Queen Pool in Lea and Chaves Counties, New Mexico, of which Graridge Corporation is operator.


Project Well No. 31-3 in the NE $\frac{1}{2}$ NW $\frac{1}{2}$ of Section 31, Township 13 South, Range 31 East, on latest test, shows a producing rate of 72 barrels per day and Project Well No. 6-11 in the NE $\frac{1}{2}$ SW $\frac{1}{2}$ of Section 6, Township 13 South, Range 32 East, on latest test, shows a producing rate of 48 barrels per day, both as a direct result of the injection of water into the formation as a part of the water flood project. In order to prevent waste, you are requested to issue your Emergency Order authorizing the production of the two aforesaid wells in excess of the normal unit allowable and to set the matter down for hearing before an examiner prior to the expiration of the Emergency Order.

You are further advised that the following described wells in the project have shown an increased rate of production as the direct result of the injection of water into the formation and you are requested to include these wells as a part of the hearing on the two aforesaid above described wells, and after hearing, to grant to each of the wells capacity allowables:
