- 3. Extend Roberts pool to include the N/2 section 3, T.17 S, R.32 E.
- 4. Extend the Bowers pool to include the N/2 section 4, T.19 S, R.38 E.
- 5. Extend the Sawyer pool to include all of section 30, T.9 S, R.38 E.
