

NOTICE OF PUBLICATION

The State of New Mexico by its Oil Conservation Commission hereby gives notice pursuant to law and the rules and regulations of said Commission promulgated thereunder of the following hearing to be held December 18, 1951, beginning at 10 a.m. on that day at Mabry Hall (the new capitol office building) in the City of Santa Fe, New Mexico.

STATE OF NEW MEXICO TO:

All parties and persons having any right, title, interest or claim in the following case or the subject matter thereof, and notice to the public.

CASE 330:

Notice is hereby given by the Oil Conservation Commission of New Mexico that a hearing will be held in relation to the Blanco (Mesa-verde) gas pool, located in San Juan County, New Mexico, at Mabry Hall, Santa Fe, New Mexico, Capitol Building, on the 18th day of December, 1951, at 10 a.m., upon the petition of Stanolind Oil and Gas Company for an order by the Commission to the following effect:

A. To make more definite and certain Section II of Order No. 799 of the Commission dated March 7, 1949, requiring the equitable production by proration units of wells in the pool, in which petition it is proposed that the following be adopted as an equitable standard:

1. That as a permanent standard commencing with the calendar year 1953 each well be allowed to produce an amount of gas based on the tested deliverability of the well against a uniform back pressure to be fixed by the Commission (but not less than the average working pressure of the pipe lines) multiplied by acreage as compared with the aggregate deliverability times acreage of all connected wells in the pool, such standard to be applied at the end of the year to the average daily production of the pool during said year.

2. In order to permit pipe lines to supply a fluctuating market demand, a tentative allowable shall be fixed at the beginning of 1953 and each subsequent year on the above standard as applied to the wells connected to each pipe line, subject to adjustment at the end of the year as set out on (1) supra.

3. That as a temporary standard for the calendar year 1952 each well shall be allowed to produce an amount of gas based on the tested open flow capacity of the well as compared with the open flow capacity of all connected wells in the pool, such standard to be applied at the end of the year to the average daily production of the pool for that year.

4. In order to permit pipe lines to supply seasonal market demand, a tentative allowable shall be fixed at the beginning of 1952 on the above standard (3) as applied to the wells connected to each pipe line, subject to adjustment at the end of the year as set out in (3) supra.

5. Each well having an underage in any calendar year shall be allowed to make it up during the next calendar year in addition to its regular allowable.

6. Each well having an overage in any calendar year shall restrict its allowable production during the next year to the extent necessary to equalize the overage, in default of which the Commission will shut in the well until the overage is equalized.

7. That provision be made for pipe line nominations, time and manner of making well tests, reports and other detailed matters.

B. To extend the boundaries of the Blanco (Mesaverde) pool, as heretofore defined and described, and make subject to the provisions of Order No. 799, being the Blanco (Mesaverde) pool rules, as they now exist or may hereafter be amended, the following described lands:

Township 29 North, Range 8 West  
Sections 1, 2, 3, 12 and 13


Township 30 North, Range 8 West  
Sections 1, 2, 3, 10, 11, 12, 13,  
14, 15, 22, 23, 24, 25, 26, 27,  
34, 35, 36

Township 31 North, Range 8 West  
Sections 25, 26, 27, 28, 29, 30,  
31, 32, 33, 34, 35, 36

to include gas wells producing from the Mesaverde formation from a pool or accumulation common to lands now included within the Blanco (Mesaverde) pool.
