FOR THE CREATION OF NEW POOLS AND EXTENSION OF
EXISTING POOLS IN LEA AND CHAVES COUNTIES, NEW MEXICO.

ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on January 20, 1954, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this ^{10th} day of February, 1954, the Commission, a quorum being present, having considered the testimony adduced at the hearing, and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That the Fowler-Drinkard and Skaggs-Drinkard Oil Pools in Lea County, New Mexico, should be established as advertised in line with testimony presented at the January 20, 1954, hearing.

(3) That extensions of previously established pools should likewise be made as advertised and verified by subsequent testimony.

IT IS THEREFORE ORDERED:

That the application of the Oil Conservation Commission be, and the same hereby is approved as follows:

(1) That a new pool be created in Lea County, New Mexico, designated as the Fowler-Drinkard Pool for oil production from the Drinkard zone, and described as:

Township 24 South, Range 37 East, NMPM
All of Sections 14, 15, 22 and 23

(Establishment of this pool is based upon the Gulf Oil Corp. Lillie Well No. 2, NW/4 NW/4 23-24S-37E discovery, said well producing from the Drinkard, with top of perforations 6320'.)

(2) That a new pool be created in Lea County, New Mexico, designated as the Skaggs-Drinkard Pool for oil production from the Drinkard zone, and described as:

Township 20 South, Range 37 East, NMPM
E/2 Section 11; W/2 Section 12

(Establishment of this pool is based upon The Texas Company's discovery well C. H. Weir 'B' No. 1, SE/4 NE/4 11-20S-37E, producing from the Drinkard with top of perforations 6856'.)

(3) That the Drickey-Queen Pool boundary in Chaves County, New Mexico, as heretofore classified, defined and described, be extended to include:

Township 14 South, Range 31 East, NMPM
SE/4 Section 9; SW/4 Section 10

(4) That the Gladiola Pool boundary in Lea County, New Mexico, as heretofore classified, defined and described, should be extended to include:

Township 12 South, Range 38 East, NMPM
SW/4 Section 19

(5) That the Littman-San Andres Pool boundary in Lea County, New Mexico, as heretofore classified, defined and described, should be extended to include:

Township 21 South, Range 38 East, NMPM
S/2 of Section 9 (lying within New Mexico)

(6) That the Monument-Blinebry Pool boundary in Lea County, New Mexico, as heretofore classified, defined and described, should be extended to include:

Township 20 South, Range 37 East, NMPM
SW/4 Section 8

(7) That the Monument-Paddock Pool boundary in Lea County, New Mexico, as heretofore classified, defined and described, should be extended to include:

Township 20 South, Range 37 East, NMPM
All of Section 8

(8) That the Saunders Pool boundary in Lea County, New Mexico, as heretofore classified, defined and described, should be extended to include:

Township 14 South, Range 33 East, NMPM
W/2 Section 33

(9) That the Eumont Gas Pool boundary in Lea County, New Mexico, as heretofore classified, defined and described, should be extended to include:

Township 19 South, Range 36 East, NMPM
All Section 12;
NE/4 and W/2 Section 13;
all Section 14;
N/2 Section 23;
NW/4 Section 24

Township 19 South, Range 37 East, NMPM
W/2 and NE/4 of Section 7;
NW/4 and E/2 of Section 8

Township 20 South, Range 37 East, NMPM
E/2 Section 10; W/2 Section 11;
SE/4 Section 21; S/2 Section 22;
S/2 Section 23; all Sections 26, 27 and 28;
E/2 Section 29; E/2 Section 33;
all Sections 34 and 35

(10) That the Blinebry Gas Pool boundary in Lea County, New Mexico, as heretofore classified, defined and described, should be extended to include:

Township 21 South, Range 37 East, NMPM
All of Sections 2, 3, 4, 9;
N/2 Section 10;
N/2 Section 11;
all of Sections 16, 21, 28 and 33

Township 22 South, Range 37 East, NMPM
All of Sections 15 and 22

(11) That the Tubb Gas Pool in Lea County, New Mexico, as heretofore classified, defined and described, should be extended to include:

Township 22 South, Range 37 East, NMPM
All Section 25

E/2 Section 19;
all Section 30
