A I recommend, in Case 686, all creations, deletions, and extensions be made as advertised. For the purpose of the record, I would like to read the top of the perforation of the creation of the Anderson Ranch-Pennsylvania Pool. The pool was created by Continental Oil Company State Ql5 No. 1-P in Section 15, Township 16 South, Range 32 East. The producing formation is the Pennsylvania, the top of the casing perforations 12,370. In support of my testimony, I would like to present plats as exhibits.
