ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on October 14, 1954, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this 17 day of November, 1954, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing, and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That the Hogback-Pennsylvanian Pool, previously designated as a gas pool, should be redesignated as an oil pool, this action having been properly readvertised.

(3) That extensions should be approved as advertised for the West Kutz-Pictured Cliffs Pool in San Juan County, New Mexico, and the East Blanco-Pictured Cliffs Pool in Rio Arriba County, New Mexico, as advertised.

IT IS THEREFORE ORDERED:

That the application of the Oil Conservation Commission of New Mexico be, and the same hereby is, approved as follows:

(a) That the Hogback-Pennsylvanian Pool, previously designated as a gas pool, should be reclassified as an oil pool for production of oil from the Pennsylvanian formation, retaining the designation Hogback-Pennsylvanian Pool, and described as:

**TOWNSHIP 29 NORTH, RANGE 16 WEST, NMPM
All of Sections 4, 5, 8 and 9**

(b) That the West Kutz-Pictured Cliffs Pool boundary as heretofore classified, defined and described, should be extended to include:

TOWNSHIP 27 NORTH, RANGE 10 WEST, NMPM
S/2 Section 33

(c) That the East Blanco-Pictured Cliffs Pool boundary as heretofore classified, defined and described, should be extended to include:

TOWNSHIP 30 NORTH, RANGE 4 WEST, NMPM
All of Section 20

DONE at Santa Fe, New Mexico, on the day and year hereinabove designated.


