WITH PRODUCTION FROM THE E. C. WINTERS  
"B", WELL NO. 3, SE/4 SW/4 SECTION 7, TOWN-  
SHIP 25 SOUTH, RANGE 37 EAST, NMPM, LEA  
COUNTY, NEW MEXICO, IN THE COOPER-JAL  
OIL POOL.**

**ORDER OF THE COMMISSION**

**BY THE COMMISSION:**

This cause came on for hearing at 9 o'clock a.m. on February 16, 1955 at Santa Fe, New Mexico, before the Oil Conservation Commission, hereinafter referred to as the "Commission".

NCW, on this 16<sup>th</sup> day of March, 1955, the Commission, a quorum being present, having considered the records and testimony adduced and being fully advised in the premises,

**FINDS:**

(1) That due notice of the time and place of hearing and the purpose thereof having been given as required by law, the Commission has jurisdiction of this case and the subject matter thereof.

(2) That applicant, Dalport Oil Corporation, is the owner of an oil and gas lease in Lea County, New Mexico, consisting of the following described acreage:

**TOWNSHIP 25 SOUTH, RANGE 37 EAST  
SW/4 of Section 7**

known as the Winters B lease.

(3) That in July, 1951, the E. C. Winters "B", Well No. 1, SW/4 SW/4 Section 7, Township 25 South, Range 37 East, NMPM, was completed as an oil well producing from the Yates section in what is now designated as the Jalmat Gas Pool.

(4) That applicant is drilling its E. C. Winters "B", Well No. 3, SE/4 SW/4 Section 7, Township 25 South, Range 37 East, NMPM, said well to be completed at an approximate depth of 3350 feet in the Queen formation of the Cooper-Jal Oil Pool.

(5) That there is no division of royalty interest on the above-described lease.

(6) That approval of this application would be in the interests of conservation and would prevent waste.

IT IS THEREFORE ORDERED:

(1) That the application of Dalport Oil Corporation for permission to commingle fluid production from the Yates zone of the Jalmat Gas Pool with fluid produced from the Queen zone of the Cooper-Jal Oil Pool on its E. C. Winters "B" Lease, SW/4 Section 7, Township 25 South, Range 37 East, NMPM, be and the same is hereby approved.

(2) That periodic tests shall be made in order to ascertain the production from each well on the lease and separate production reports (Form C-115) shall be submitted on each well.
