Gentlemen:

Reference is made to your application for approval of a 480-acre non-standard gas proration unit in the Jalmat Gas Pool consisting of the following acreage:

Twp. 21 South, Rge. 36 East, NMPM  
N/2 and SE/4 of Section 34

It is understood that this unit is to be ascribed to your William A. Ramsey State Well No. 17, located 1980' from the West and North lines of Section 34, Township 21 South, Range 37 East, NMPM, Lea County, New Mexico.

Inasmuch as you are the only operator within 1500' of the subject well, and the only operator in the subject section, it is possible for immediate approval to be granted. Therefore, by authority granted me under provisions of Rule 5, Section (b)-5 of the Special Rules and Regulations of the Jalmat Gas Pool, as set forth in Order R-520, you are hereby authorized to operate the above described acreage as a non-standard gas proration unit, with allowable to be assigned thereto in accordance with pool rules, based upon the unit size of 480 acres.

Gentlemen:

Gulf Oil Corporation hereby makes application for approval of a non-standard gas proration unit comprising the N/2 and SE/4 of Section 34, T21S, R36E, Lea County, New Mexico, and in support thereof states the following facts:

(1) Gulf Oil Corporation is the owner and operator of an oil and gas lease known as the William A. Ramsay State Lease which comprises the 480 acres above described.

(2) The William A. Ramsay State #17 located 1980 feet from the West line and 1980 feet from the North line, Section 34, T21S, R-36E ~~R37E~~ Lea County, New Mexico, was completed on June 30, 1954, to a total depth of 3885 feet, plugged back to 3675 feet as a gas well in the Jalmat Gas Pool. The applicant proposes to use this well as the unit well.

(3) The proposed non-standard gas proration unit will meet the requirements of Rule 5(b) of the Oil Conservation Commission Order No. R-520 as follows:

(a) Contiguous quarter-quarter sections will comprise the unit.

(b) The proposed unit lies wholly within a single governmental section.

(c) All acreage within the proposed unit may reasonably be presumed productive of gas.

- (d) The length or width of the proposed unit does not exceed 5280 feet.
- (e) Gulf Oil Corporation is the lessor of the entire section described and the well is so located in the unit that the only operator within 1500 feet of the well is another Gulf Oil Corporation Gas Unit.

In view of the existence of the facts herein stated and compliance with the provisions of Rule 5(b) of the Oil Conservation Commission's Order No. R-520, Gulf Oil Corporation requests that the Secretary of the Commission approve the above described non-standard gas proration unit.



Gentlemen:

On December 27, 1954, by virtue of the provisions of Administrative Order NSP-59, I approved the formation of a non-standard gas proration unit consisting of the following described acreage in the Jalmar Gas Pool:

Section 34, Township 21 South, Range 36 East  
N/2 and SE/4

Information available to me at this time indicates that I exceeded the authority granted to me by the provisions of Rule 5-b of Order R-520, (Jalmar Pool Rules) due to the fact that the third paragraph of Rule 5-2 specifically limits the maximum amount of acreage that may be assigned to a gas well, the amount being governed by the well location.

The formation of a 480-acre non-standard proration unit with your W. A. Ramsay Lease, Well No. 17, located 1980 feet from the North line and 1980 feet from the West line, is contrary to the provisions of this rule.

On February 16, 1955, this Commission will hold hearings directed to you as operator for you to show cause why the acreage assigned your W. A. Ramsay Well No. 17, SE/4 NW/4 Section 34, Township 21 South, Range 36 East, NMPM, Jalmar Gas Pool, should not be reduced to 320 acres in accordance with the provisions of Paragraph 3 of Rule 5-a of Order R-520. The description of this 320-acre unit is as follows:
