ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a. m. on June 28, 1955, at Santa Fe, New Mexico, before the Oil Conservation Commission, hereinafter referred to as the "Commission."

NOW, on this 27<sup>th</sup> day of July, 1955, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing, and being fully advised in the premises,

FINDS:

- (1) That due public notice having been given as prescribed by law, the Commission has jurisdiction of this cause and the subject matter thereof.
- (2) That extensions as advertised should be approved for the Fulcher-Kutz Pictured Cliffs Gas Pool and the Aztec-Pictured Cliffs Gas Pool.
- (3) That extension of the Ballard-Pictured Cliffs Gas Pool, as described in Section (b) of the advertisement for the subject hearing be deleted from this order, as the advertised extension is included within the horizontal limits of the Ballard-Pictured Cliffs Pool as delineated in the Commission's order entered in Case No. 908.

IT IS THEREFORE ORDERED:

That the application of the Oil Conservation Commission upon its own motion be, and the same hereby is, approved as follows:

- (a) That the Fulcher-Kutz Gas Pool, as heretofore classified, defined and described should be extended to include therein:

TOWNSHIP 28 NORTH, RANGE 10 WEST, NMPM  
SW/4 of Section 24

(b) That extension to the Ballard-Pictured Cliffs Gas Pool, is hereby deleted.

(c) That the Astec Pictured Cliffs Gas Pool, as heretofore classified, defined and described should be extended to include therein:

TOWNSHIP 28 NORTH, RANGE 10 WEST, NMPM  
NW/4 of Section 13  
N/2 of Section 14

TOWNSHIP 28 NORTH, RANGE 9 WEST, NMPM  
SE/4 of Section 31


