In the matter of the application of the Oil Conservation Commission of New Mexico upon its own motion for an order for the creation of new pools, and the extension of existing pools in Lea, Chaves, and Eddy Counties, New Mexico, and giving notice to all persons and parties interested in the subject matter thereof to appear and show cause why such creations and extensions should not be made.

(a) Create a new pool in Lea County, New Mexico, classified as an oil pool for Wolfcamp production, designated as the East Bagley-Wolfcamp pool, and described as:

Twp. 12 South, Range 34 East  
All of Section 9

and such other etc.

(b) Create a new pool in Eddy County, New Mexico, classified as an oil pool for Delaware production, designated as the Carlsbad-Delaware pool, and described as:

Twp. 21 South, Range 26 East  
NE/4 of Sec. 24

and such other etc.

(c) Create a new pool in Lea County, New Mexico, classified as an oil pool for San Andres production, designated as the South Carter-San Andres pool, and described as:

Twp. 18 South, Range 39 East  
N/2 of Section 8

and such other etc.

(d) Create a new pool in Lea County, New Mexico, classified as an oil pool for Devonian production, designated as the Fowler-Devonian pool, and described as:

Twp. 24 South, Range 37 East  
SE/4 of Section 9

and such other etc.

(e) Create a new pool in Lea County, New Mexico, classified as an oil pool for Wolfcamp production, designated as the South Gladiola-Wolfcamp pool, and described as:

Twp. 13 South, Range 38 East  
SW/4 of Section 6

and such other etc.

(f) Create a new pool in Lea County, New Mexico, classified as an oil pool for Grayburg production, designated as the Grayvac pool, and described as:

Twp. 17 South, Range 33 East  
NE/4 of Section 4

and such other etc.

(g) Extend the Artesia pool boundary in Eddy County, New Mexico, to include therein:

Twp. 17 South, Range 28 East  
NE/4 of Section 35

Twp. 18 South, Range 27 East  
W/2 of NW/4 of Sec. 35

and such other etc.

(h) Extend the Caprock-Queen pool boundary in Chaves County, New Mexico, to include therein:

Twp. 14 South, Range 31 East  
E/2 E/2 of Section 17

and such other etc.

(i) Extend the Blinebry oil pool boundary in Lea County, New Mexico, to include therein:

Twp. 22 South, Range 37 East  
NE/4 NE/4 of Section 26

and such other etc.

(j) Extend the Dollarhide-Drinkard pool boundary in Lea County, New Mexico, to include therein:

Twp. 25 South, Range 38 East  
S/2 of Section 5, and that part of S/2 of  
Sec. 4 lying within New Mexico

and such other etc.

(k) Extend the Eumont pool boundary in Lea County, New Mexico, to include therein:

Twp. 18 South, Range 37 East  
All of Section 32

Twp. 19 South, Range 37 East  
SW/4 of Section 35 W/2 SE/4 of Section 27

Twp. 20 South, Range 35 East  
E/2 E/2 of Section 4  
NE/4 NE/4 of Section 9  
N/2 NW/4 of Section 10

Twp. 21 South, Range 35 East  
SE/4 of Section 11

and such other etc.

(l) Extend the Vacuum pool boundary in Lea County, New Mexico, to include therein:
